 - The trash is yours, so please take it with you.
 - Return all chairs & tables where you find them.
 - All buildings and gates are to be closed when leaving.
- Deposits will be returned if everything is found in a neat, clean, and respectable condition.
- If any extra cleaning needs to be done, lights or electrical units are left on, any damages found, or there are items missing, such expense may be deducted from deposit.

Proof of Insurance is required for all activities. Minimum Insurance needed is \$500,000.
